Thank you for applying for the Jeff Annas Memorial Scholarship. The Professional Firefighters/Paramedics Benevolent Fund, Inc. will be awarding eight (8), five hundred dollar (\$500) scholarships and one (1) one thousand dollar (\$1,000) to assist local high school seniors in pursuing their college education. Payment will be made directly to a qualified educational institution once the student is enrolled.

The following guidelines must be adhered to in order to qualify:

1. The applicant must be graduating from a public, private or home school within Palm Beach County and entering college as a full-time student.
2. You must have a cumulative GPA (not HPA) of at least 2.50.
3. A copy of your parent's or guardian's 2011 tax return must be included. If the 2011 tax return is unavailable, attach a copy of the 2010 tax return and the 2011 W-2 form(s). If parents are divorced or file separately, send tax information of both parents. *Please remove or blackout all references to Social Security numbers on the tax forms.*
4. Include two (2) letters of recommendation from faculty members (limit to one page each).
5. Your guidance counselor will need to complete the information on Page 3
6. Compose and type a five hundred (500) word essay including the following:
 - a) Describing you academic goals
 - b) Describing how you serve your community
 - c) Explaining what makes you unique or especially deserving of this award

APPLICATION DEADLINE: April 30, 2012

No applications will be accepted after April 30, 2012. All applications must be received or postmarked by said date. Applications received or postmarked after this date will not be eligible for consideration.
